Second oil rig made indigenously by MEIL is ready to be handed over to ONGC for its Kalol oil field Gujarat."Reducing dependence on energy imports is a must for the success of Make in India and Atmanirbhar Bharat. MEIL is proud to be contributing to both the

initiatives and playing its part in boosting domestic oil production and securing the country's energy future," P Rajesh Reddy, Vice-President, MEIL, said after a visit to the second oil rig made by MEIL for ONGC near Ahmedabad in Gujarat. The infra major, which is the first Indian private player to manufacture oil and gas rigs, is gearing up to deliver 47 oil and gas rigs to ONGC Limited by 2022 end.
